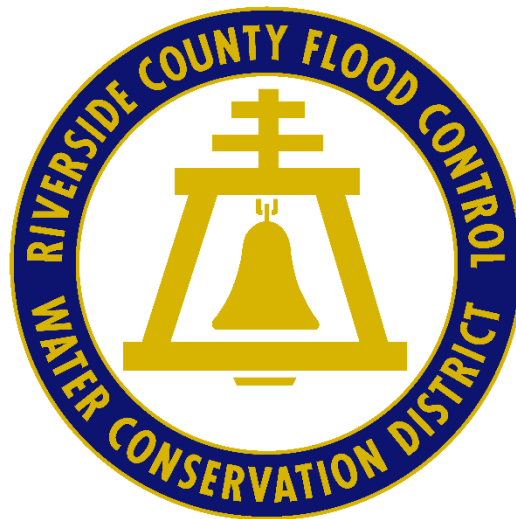

The bid shall be delivered (no e-mail delivery) to the District at the address stated below on or before 1:30 p.m. on the closing date. The RFB number, title, and closing date and time shall appear on both the envelope and the bid cover sheet. Under no circumstances will a bid be accepted after the closing date and time.

3.0 License Required Clarification: ~~The following License is required for the project C-22, C-21, or B-General Contractor who also carries a C-22 or will subcontract a C-22 Contractor. (The B-License covers the C-21 for the type of demolition required on this project.)~~ **The original license requirement of “License B General Building Contractor is correct. 4.0 Item 2 page 2 of the Original RFB Correcting a typo in item “a.” the Drawings state please note it should read RFB FCARC-00185.

4.1 Item “c” Vendor Registration, must be requested by the vendor through the Administrator of this RFB, Marilyn Weisenberg. *The same correction for item 1 under Instructions to Bidders page 5 of the original RFB.

5.0 Item 5 **TIMELINES** on page 3 of the Original RFB FCARC-00185, is updated with a new Deadline for Bids. All Bids must be submitted on **April 16, 2024**, no later than 1:30pm.

6.0 Through out the Exhibit A/Scope of Work (SOW), links are provided detailing sinks, counter tops, cabinets etc. Please note the RFB follows the rule of “Or Equal To”. Specifications must be provided as backup that the alternative product is equal to the called-out items in the SOW

7.0 Please note the ceiling should be priced based on a Painted Drywall Ceiling, knockdown texture.

8.0 Please note the Epoxy coated flooring should be bid as a roll-up on the walls eliminating all baseboards.

9.1 Can we please request the following information Base Cabinet Height
Wall 1 & Wall 2?

District Response: Please use a standard height of 34.5 inches and combined with the countertop the height should be 36” total.
